#AFSCMEinAnnapolis: Recapping the 2025 Legislative Session

On April 7, Maryland's 447th Legislative Session came to a close. In just a few months, AFSCME members made our voices heard testifying at budget and bill hearings, showing up for Lobby Nights in Annapolis, and calling our legislators to support pro-worker legislation.

Our actions paid off! In the end, we fought back attempts to take away our alreadynegotiated raises or balance the budget on our backs, and we made progress on key legislation. In just a few weeks, Governor Moore will be signing the Davis Martinez Public Employee Safety and Health Act into law, a bill that our union championed that will make ALL public employers in Maryland accountable to providing safe workplaces.



Recapping Our Annual Public Safety Summit

On April 24-26, nearly 100 members joined our annual Public Safety Summit, hosted in Salisbury this year! Our Public Safety Summit brings together many of our local unions that keep our communities safe. The summit is a space to navigate challenges, celebrate progress, and strengthen our sense of justice through collaboration and education.

- AFSCME Local 1803 held a day of action in early April to sign up new members at the Department of Agriculture.

- Local 1427 has been rolling up their sleeves and working hard to inform and mobilize our members!
- AFSCME members who work for various Maryland Department of Health (MDH) facilities had a great introductory meeting with the new MDH Secretary, Dr. Meena Seshamani. We discussed the biggest challenges and opportunities facing our state hospitals and health departments and how we can work together moving forward.
- Howard County Library Workers United members unanimously ratified their first union contract in April, paving the way for fair compensation, expanded workplace rights, and more!

Member Spotlight: Alonzo Smith

For over a decade, AFSCME Local 1209B member Alonzo Smith has helped make Bowie a great place to live. Alonzo has been an operator at the city's Wastewater Treatment Plant for the last 3 years, but before that, he worked for the Parks and Grounds Division where he maintained the city's parks, sidewalks, buildings, and more. "I love my job, and I'm doing something different every day. When you find something you enjoy doing, you don't mind doing it," says Alonzo.

When Alonzo first started working for the City of Bowie, a supervisor on the Stormwater team in the Public Works Department encouraged him to join his union. Now, 10 years later, Alonzo regularly recruits new members and talks to his coworkers about the value and potential of their union.

This past March, Alonzo and his fellow Local 1209B members attended an AFSCME Lobby Night for the first time in Annapolis to advocate for the passage of HB 1509/SB 976, which would have standardized collective bargaining rights for county and municipal workers across Maryland. Having experienced contract negotiations with the City of Bowie beforehand, Alonzo reflected, "We have a labor agreement in place but we don't have laws in place to honor the process. **Employers shouldn't be dragging things out until the end without us having a fair shot in the process."** Although the legislation did not pass, Alonzo and other AFSCME members helped generate strong interest in the legislation among senators and delegates for next year.

Ultimately at the end of the day, becoming an active member of his union is personal for Alonzo. "I don't want my son to work as hard as I do. This is about taking care of future generations, and when someone comes behind us, I want there to be laws in place so our union has fair ground to stand on and a way to speak out."
