### **Higher Education Lobby Night**

Last night, almost 50 members from campuses across Maryland came together to pass one of our most important legislative priorities this session: USM bargaining consolidation. AFSCME Council 3 represents 6,500 higher education employees and over 20,000 regular state employees. For state employees, despite wide differences in job duties, we have one contract. But under the current system in higher education, we negotiate 15 different contracts with each individual campus within the University System of Maryland, even though jobs are very similar from campus to campus. This is an inefficient system preventing comprehensive work policies and perpetuating divisions on campus leading to vastly different experiences for frontline workers.

Furthermore, with individual campuses, we can only negotiate non-wage issues, which in turn can be rejected by the USM Board of Regents. Even then, many individual campuses have declined to negotiate non-wage issues, including health and safety issues during a pandemic. COVID-19 doesn't care which campus it hits! That's why this legislation is urgently needed to make sure each campus has a detailed and unified response to the pandemic to keep frontline staff safe.

#### **Telework Reform Policy: Take Action**

When the pandemic began in March of last year, AFSCME members rose to the challenge despite inadequate technology and infrastructure for remote work. Throughout the pandemic, our members have shown that we can still be productive while teleworking. The flexibility that telework offers is an important employee benefit that helps with retaining and recruiting staff which the state has had documented difficulty with.

The State of Maryland has already invested in the equipment. We don't want to go back to where it was before the pandemic where none of our members had access to teleworking. The reality is that there is a telework divide. Black and Brown workers have less access, so do lower-income workers. This is why it is urgent that we pass Telework Policy Reform this year!
